**RESOLUTION DESIGNATING EMERGENCY SERVICE PROVIDERS FOR LONDON GROVE  
TOWNSHIP**

**RESOLUTION NO. 821**

A RESOLUTION OF THE TOWNSHIP OF LONDON GROVE, COUNTY OF CHESTER,  
COMMONWEALTH OF PENNSYLVANIA.

**WHEREAS**, the Board of Supervisors of London Grove Township is responsible under the Second Class Township Code for the public safety of the residents of London Grove; and

**WHEREAS**, the Board of Commissioners of the County of Chester has requested that London Grove Township provide the Board of Commissioners with a resolution outlining the methods and agencies chosen to fulfill the public safety needs of London Grove Township for the efficient administration of the emergency communications system of the Chester County Department of Emergency Services.

**NOW THEREFORE, BE IT RESOLVED**, that the West Grove Fire Company and London Grove Township (If Applicable) will provide fire protection; and,

**FURTHER, BE IT RESOLVED**; that London Grove Township embraces technology and the most efficient and effective ways to deploy responses agencies. London Grove Township approves of the use of Automatic Vehicle Location services for Second Due response, or as determined by the Township's Emergency Services Committee; and,

**FURTHER, BE IT RESOLVED**; that the West Grove Fire Company and London Grove Township (if applicable), will each provide rescue service; and,

**FURTHER, BE IT RESOLVED**, that the West Grove Fire Company and London Grove Township (If Applicable), will each provide Basic Life Support (BLS) service; and,

**FURTHER, BE IT RESOLVED**; that Southern Chester County Emergency Medical Services (SCCEMS) provide Advanced Life Support Services (ALS); and,

**FURTHER, BE IT RESOLVED** the Pennsylvania State Police will provide full time police protection; and,

**FURTHER, BE IT RESOLVED** that Tim Shannon is designated as Emergency Management Coordinator, and Dawn Maciejczyk, as the Assistant Emergency Management Coordinator; and

**FURTHER, BE IT RESOLVED** that the Board of Supervisors have reviewed and revised, if necessary, and adopted London Grove Township Emergency Operations Plan; and has reviewed and adopted the National Incident Management System as a common operating practice.

AND FURTHER, BE IT RESOLVED, the contact person between said organizations and the Chester County Department of Emergency Services shall be Tim Shannon, London Grove Township Emergency Management Coordinator, and Dawn Maciejczyk, London Grove Township Assistant Emergency Management Coordinator.


